Recommended Fee Schedule

(Based upon a 50 minute session - Not including GST)

These recommendations are based on what is approximated to be fair market value at the time of writing and are a guide for clinicians and members of the public. It is understood that there may be fluctuation depending upon individual and regional circumstances. Actual fees should be discussed, negotiated and/or clarified prior to entering into a contractual relationship.

Group Therapy (per individual)	50.00
Custody & Access, Forensic Assessments Workshops/Seminars At regular hourly session rate with recommended minimum charge of four hours. Include Research and Preparation time in total fees when calculating contract service price	
Letters, Forms & Clinical Service including Legal Services	
NOTE: Time and cost estimate to be provided prior to commencing administrative services	
Filling out <i>Ordinary Printed Form</i>	110/hour
<i>Short one page letter</i> or less for any lay person e.g. Lawyer, Insurance Representative or similar.	110/hour
Short <i>Summary of Facts Report</i> generally including symptoms, history, diagnosis, and present condition.	110/hour
<i>Summary of Facts Report including Expert Opinion</i> and which may or may not include <i>Recommendations</i> . Generally includes all of the facts for a Summary report together with detail regarding opinion, prognosis, potential long term consequences and potential complications.	110/hour
<i>Review of Records by Clinician</i> such as may be required for photocopying preparation and other miscellaneous purposes.	110/hour
<i>Photocopying of Records - per page (8-1/2" x 11")</i>	.25
<i>Photocopying of Records - per page (11" x 17")</i>	.30

Expert Preparation and/or Evidence in Court/Hearings	
<i>Expert testimony in court, per day</i> (as court involvement often can involve waiting time, wait time at the court house, is included as paid time)	1,320.00
<i>Expert testimony in court, per half-day</i> (as court involvement often can involve waiting time, wait time at the court house, is included as paid time)	880.00
<i>Court preparation by expert witness, per hour</i>	165.00
<i>Failure of notification</i> of court adjournment or out of court settlement. (This fee item applies when the client or legal counsel fails to provide written notice with three full working days notice of cancellation of court or other legal appearance.)	1,650.00
TRAVEL TIME & MILEAGE:	
Travel Time (per hour - billed from the time the clinician leaves the home or office to go to court or other legal appointment and from the time the clinician leaves the courthouse or meeting place until they return to the beginning place or approximately the same location. If overnight accommodation is required as the clinician is unable to return on the same day, the travel time ends at 6:00 pm and begins the following day at 9:00 am or the time the clinician leaves the hotel, whichever is earlier)	110.00
